

2024 Reflections Advertising Insert Contract

Cost: Insertion fee is \$680 per month/per insert. A discounted rate of \$370 will be extended to advertisers running a 1/2 page or full page advertisement in the body of *Reflections* during the same month. Only five (5) inserts will be sold on a first come, first served basis, in any given month, so please contact the Advertising Administrator to determine availability. Reservations can only be held with a signed contract and full payment in advance.

Materials Specifications: Inserts should be standard letter size (8.5" x 11") only. No larger and no smaller.

Notices: Completed contract, insert artwork and payment must be received by the reservation deadline (see chart below or visit SolivitaAdvertising.com). Insert delivery deadlines vary, but are typically around the third week of the month prior to publication month. Contact the Advertising Administrator in advance for quantity. Email contract and insert artwork to SolivitaAdvertising@SolivitaClub.com. All costs of collection, including reasonable attorney's fees incurred by Solivita, shall be reimbursed by the Advertiser. No political advertisements of any kind will be accepted.

Insert Approval, Copies and Shipment: Prior to the insert being copied and shipped, insert artwork needs to be emailed to SolivitaAdvertising@SolivitaClub.com for approval. Once approval is given, the insert can be copied and shipped to Wilman De Jesus at: Solivita Communications Department, 395 Village Drive, Suite C, Kissimmee, FL 34759. Inserts cannot be stored (at Solivita), therefore only the number of flyers determined by the contracted month should be delivered to Solivita.

Cancellation: Solivita may cancel the insert contract on 10 days written notice to Advertiser. Advertiser may only cancel the contract with written notice to Solivita <u>before</u> the insert delivery deadline. If such cancellation occurs, Advertiser's insert will not be included in the next scheduled publication. Solivita reserves the right to reject and/or discontinue any advertisement at any time, for any reason whatsoever in its unfettered discretion. In the event of rejection and/or discontinuance, Solivita will issue Advertiser a full refund.
